Among the 21 experts composing the PLH panel, 2 have one or more conflict s of interest, the declared and publicly available information was insufficient to assess the case of 2 experts and 17 experts do not have any declared conflict of interest. The total number of interests screened is 46, 3 were determined to constitute a conflict of interest, 37 as not and 6 could not be assessed for lack of declared and publicly available information.
